Police Chief Minnis provided an update on the following: MDT's will be operational in each police vehicle by March 1; He will soon launch the "Neighbor2Neighbor" program.

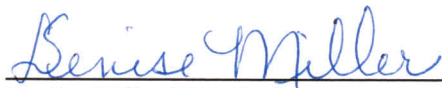
Commissioner Garland (Finance) –
