Commissioner Vowels (Police) – No Report

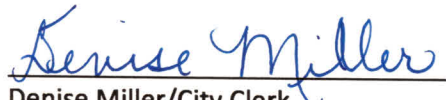
Commissioner Garland (Finance) –

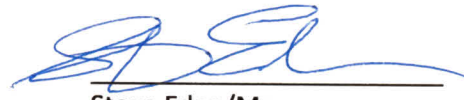
