Mayor Eden called the meeting to order at 7:00 pm.

Pledge

Mayor Eden presented, for approval, the minutes from November 6, 2017 regular meeting. After review, **Commissioner Vowels made the motion to accept the minutes as presented. Commissioner McDowell seconded.** Motion carried unanimously.

Mayor Eden recognized the Board Attorney's Report:

Board Attorney Brammell presented Ordinance #2017-007 pertaining to Text Amendment for Nonconforming Structures. 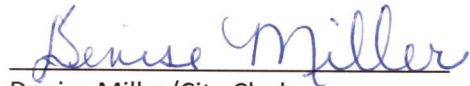

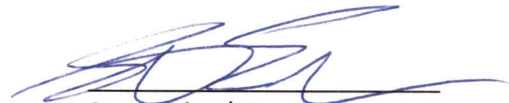
Commissioner Garland (Finance) – Absent
