REGULAR CITY MEETING MINUTES

Present: Mayor Eden, Commissioners Hesse, McDowell & Vowels, City Attorney Hays as legal counsel, City Administrator Eaton and City Clerk Miller.

Absent: Commissioner Garland

Mayor Eden called the meeting to order at 7:00 pm.

Pledge

Mayor Eden presented, for approval, the minutes from September 4, 2018 public hearing and regular meeting. After review, **Commissioner Vowels made the motion to accept both sets of minutes as presented. Commissioner Hesse seconded. Motion carried unanimously.**

Mayor Eden recognized J.D. Chaney, on behalf of the Kentucky League of Cities, to present to State Representative Rob Rothenburger the "Friends of Cities" award. Representative Rothenburger made a few statements thanking the City of Simpsonville for their cooperation over the years.

Mayor Eden recognized Reverend Farris, on behalf of the Human Rights Commission and along with other board members, who presented to the Commission, for consideration, the Human Rights Commission recommendation of an ordinance amendment. No action taken.

City Administrator Eaton presented to the Commission, for approval, Pace Contractor's Payment Request #10. **Commissioner Vowels made the motion to issue payment #10 for \$177,214.81. Commissioner McDowell seconded. Motion carried unanimously.**

City Administrator Eaton presented to the Commission a donation request from Simpsonville Baptist Church for the Christmas Village Toy Store. City Administrator Eaton recommended a \$100 donation. **Commissioner Hesse made the motion to issue a \$100 donation to Simpsonville Baptist Church Christmas Village Toy Store. Commissioner Vowels seconded. Motion carried unanimously.**

Mayor Eden recognized the City Clerk's Report: No Report

Mayor Eden Report:

Mayor Eden presented to the Commission a 3-year financial commitment request from Leadership Shelby in the amount of \$9,000.00. After discussion, **Commissioner Hesse made the motion to accept the 3-year commitment of \$9,000, issuing a \$3000 payment each year for the next 3 years. Commissioner Vowels seconded. Motion carried unanimously.**
