

**CITY OF SIMPSONVILLE  
REGULAR CITY MEETING MINUTES  
CITY COMMISSION ROOM  
JUNE 7, 2011 7:00 PM**

Present: Mayor Eden, Commissioners McDowell, Vowels, City Administrator Eaton, Police Chief Chappell, Officer Desoto, and City Clerk Batliner. Guests: A sign in sheet was passed around for those present to sign.

Absent: Commissioners Cummins and Wise, and City Attorney Hays.

Mayor Eden called the meeting to order 7:00 pm.

Pledge

Mayor Eden recognized Noah Hart: Mr. Hart address the Mayor and Commission to relay that there are varying opinions on the parking restrictions from the residents of Todd's Station. City Administrator Eaton explained Ordinance # 2010-009 pertaining to the parking.

Mayor Eden presented the minutes from May 18, 2011 regular city meeting and the May 18, 2011 Public Hearing for approval and everyone was furnished a copy. **Commissioner McDowell made the motion to accept the minutes as presented. Commissioner Vowels seconded.** Motion carried unanimously.

Mayor Eden presented Ordinance # 2011-004 pertaining to the Garbage Franchise for the first reading and everyone was furnished a copy. City Administrator Eaton advised there will be one change in the Ordinance #2011-004, and the one change is the contract length is changing from 5 years to 10 years. **Commissioner Vowels made the motion to accept the first reading on Ordinance #2011-004 pertaining to Garbage Franchise. Commissioner McDowell seconded.** Ordinance # 2011-004 will be placed on the June 15, 2011 agenda.

Mayor Eden presented a contract from the HBM Engineers for the Downtown Project for approval and everyone was furnished a copy. City Administrator Eaton recommended the Commission accept the contract. **Commissioner McDowell made the motion to accept contract with HBM Engineers and authorized Mayor Eden to execute the contract. Seconded by Commissioner Vowels.** Motion carried unanimously.

Mayor Eden recognized the Commissioner's Report:

**Commissioner Wise-Absent.** City Administrator Eaton advised the engineers were marking sewer lines today on Main Street.

**Commissioner McDowell** had nothing at this time.

**Commissioner Cummins –Absent.**

**Commissioner Vowels** advised:

- The Simpsonville Fall Festival will be Saturday September 10, 2011.
- The parks department have soccer and basketball day camps going on.

- A new concession stand in the process of being built.
- Tuck pointing has been done on the school building.

Mayor Eden recognized the Police Department's Report: Absent.
