

**CITY OF SIMPSONVILLE
REGULAR CITY MEETING MINUTES
CITY COMMISSION ROOM
MARCH 3, 2016 7:30 PM**

Present: Mayor Eden, Commissioners Cummins, Garland, Hesse, and Vowels. City Attorney Brammell was in attendance as legal council. City Administrator Eaton and City Clerk Batliner. Guest: Sentinel News and Ken Hudson.

Mayor Eden called the meeting to order at 7:30 pm.

Mayor Eden presented the minutes from February 18, 2016 regular city meeting for approval and everyone was furnished a copy. **Commissioner Vowels made the motion to accept the minutes as presented. Commissioner Hesse seconded.** Motion carried unanimously.
