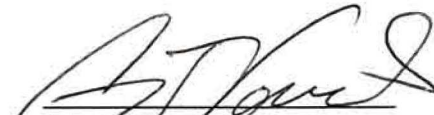
Mayor Vowels recognized the City Administrator's Report:
